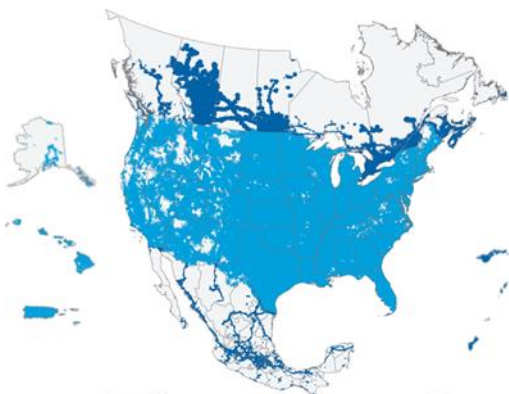

Customers using the AT&T commercial core will have different coverage and network capabilities than customers using the FirstNet Evolved Packet Core, as more fully described in the Agency Paid User's underlying FirstNet Mobile Plan. ** "Unlimited" refers to domestic usage of Enhanced PTT on the AT&T domestic 4G LTE network and the 4G LTE networks of rural providers connected to the FirstNet Evolved Packet Core and usage on roaming partner networks in Canada and Mexico. FirstNet Enhanced PTT Bolt-On Plan usage does not count as part of the usage or data plan allowance under a device's FirstNet Mobile Plan.

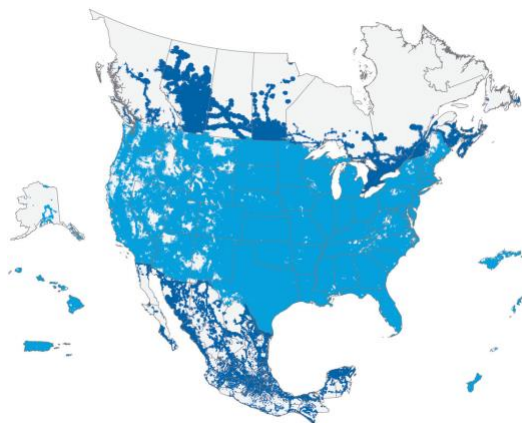

FIRSTNET ENHANCED PTT BOLT-ON PLAN (FIRSTNET EVOLVED PACKET CORE): Bolt-on Plans require a FirstNet Subscriber Information Module (SIM) in a FirstNet Capable device provisioned with a FirstNet Mobile Plan. **Eligibility:** This FirstNet Enhanced PTT Bolt-On Plan is available only to State and Local Government Extended Primary Public Safety Entities and their Agency Paid Users only as a bolt-on feature to lines of service. **Definitions:** **Public Safety Entities** are entities authorized by the First Responder Network Authority to obtain services under the FirstNet program. **Primary Users** are those Public Safety Entities that are authorized to use the FirstNet program for law enforcement, fire protection, emergency medical services, Public Safety Answering Point/dispatching and emergency management. **Extended Primary Users** are those Public Safety Entities that are not Primary Users, but who may be called upon to support Primary Users during the time of an emergency. **Agency Paid Users** are individual employees and contractors of a Public Safety Entity who are granted access to a FirstNet Mobile Plan for which the Public Safety Entity is financially responsible. **Plan use is limited to the United States, Puerto Rico, US Virgin Islands, Canada, and Mexico.**

BUSINESS AGREEMENT: Eligible customers must have a qualified AT&T wireless service agreement ("Business Agreement"). Plans are subject to the terms of (1) the Business Agreement; (2) the AT&T FirstNet Guide (the "Service Guide") when incorporated into the Business Agreement; and (3) this document and all other related Sales Information. **Pricing:** Prices are for service only. Net \$3.00 Monthly Service Charge is included in the plan price. A feature charge per line is credited back \$2 each month. The FirstNet Enhanced PTT Bolt-on Plan(s) are not eligible for any service discount or other discount set forth in the Business Agreement. **Devices:** Sold separately. **Plan use is limited to the United States, Puerto Rico, US Virgin Islands, Canada, and Mexico.**
