

# International Roaming Packages

**International roaming by qualified Public Safety Entities and their Authorized Users outside of Canada, Mexico and the Pacific Territories (American Samoa, Guam and the Commonwealth of the Northern Mariana Islands) require the purchase of an international roaming package\*. International roaming locations are extensive and additional roaming locations will be supported in the future. The list of included countries for each package can be found at [www.firstnet.com/intlcountries](http://www.firstnet.com/intlcountries).**

\*The packages described in this brochure require a FirstNet Capable device provisioned with a FirstNet Trio Subscriber Identification Module (SIM) card for use on the FirstNet Evolved Packet Core. If you have a device provisioned with an AT&T SIM card for use on the AT&T commercial core, please see [att.com/global](http://att.com/global) for available international roaming packages.

## INTERNATIONAL DAILY PASS

Pay a low daily fee to use data, talk, and text from your domestic FirstNet Mobile plan when roaming in select countries. Just add it once to make it available whenever you travel in included countries and then pay just \$10 a day only on the days you use your device.

**INTERNATIONAL ROAMING PACKAGES: Eligibility:** Available only to qualified Public Safety Entities that have a valid agreement with AT&T for the FirstNet Solution ("Qualified Agreement") and their authorized Agency Paid Users and Subscriber Paid Users. Requires a 4G LTE-compatible, FirstNet Capable device provisioned with a FirstNet Trio SIM card and a qualified FirstNet Mobile plan for domestic use on the FirstNet Evolved Packet Core. If you have a device provisioned with an AT&T SIM card for domestic use on the AT&T commercial core, please see [att.com/global](http://att.com/global) for available international roaming packages. For Subscriber Paid Users, certain additional eligibility restrictions apply which may be based on service tenure, payment history and/or credit. AT&T, in its sole discretion, may block your ability to use your device while roaming internationally until eligibility criteria are met. Availability and quality of coverage and services while roaming are not guaranteed.

**INTERNATIONAL DAILY PASS:** Eligible domestic FirstNet Mobile postpaid wireless plan required. Provisioning: Must be provisioned on a per-device basis before use. Once you add this option to your device, International Daily Pass will stay on your account until you remove it at <https://localcontrol.firstnet.att.com> or call 800.574.7000 or dial 611 from your AT&T mobile

phone. **Use and Assessment of Fee:** Once you add this option to your device, the first time you use data or voice, or send a text message in an

International Daily Pass country, you'll automatically be charged a \$10 daily fee. The fee covers additional data, voice or text messages sent for 24 hours from the initial use in any International Daily Pass country during that period. You'll be charged an additional \$10 fee for all subsequent 24-hour periods in which you use data or voice or send a text message on a device set up with International Daily Pass in an International Daily Pass country until you cancel the service. Such incidental data usage may trigger the \$10 daily fee. To avoid unintended use of International Daily Pass, turn off the roaming feature for your smartphone or device. Billing:** Your International Daily Pass data and voice usage will generally be applied to the monthly bill period/data amount of your domestic plan at the time it's used. However, because of the way we receive reporting from our international roaming carriers, voice or data usage may not match your exact dates of travel, and voice or data usage may be applied to your subsequent bill period. **Data:** International Daily Pass

lets you use data in all included International Daily Pass countries without roaming charges. Data will be drawn from your domestic plan allowance. Additional or promotional data may not be available for use in destinations outside the U.S. Actual data speeds vary by device and location.

**Data Overage:** If you go over the amount of data in your qualified plan or other allowances during your bill period, overage charges will apply. **Voice:** For phones. International Daily Pass allows you to use the calling features of your domestic FirstNet Mobile plan within and between included International Daily Pass countries, from included countries to the U.S. Calls and minutes of usage will be drawn from your domestic voice plan allowance. You may be charged for calls to special or premium service numbers. **Calls to other countries:** Calls from included countries to non-included countries will incur International Long Distance (ILD) charges. Per-minute pay-per-use rates apply unless you add an International Long-Distance service package to the device making the calls. Rates subject to change without notice. International Daily Pass allows you to use the standard messaging features of your FirstNet Mobile domestic plan within and from an included country. Includes an unlimited number of messages up to 1MB in size within and from an International Daily Pass country to more than 190 countries for text messages, and more than 120 countries for picture and video messages. We may add, change and remove included countries at our discretion without notice. Messages sent through applications like iMessage or Hangouts may incur data or other charges. For details, go to [att.com/text2world](http://att.com/text2world). **Service restrictions:** Only available for use with eligible devices (i.e., smartphones, feature phones (basic/messaging phones) and tablets). International use aboard cruise ships and airlines is not included; see pay-per-use rates. **Canada, Mexico and the Pacific Territories:** You won't be charged the \$10 fee for International Daily Pass in Canada, Mexico or the Pacific Territories, as your domestic FirstNet Mobile plan includes usage in those locations at no additional charge. **Miscellaneous:** For devices with an active International Daily Pass and an International Pass package, International Daily Pass charges will apply in included International Daily Pass countries even though you also have an International Pass package. Data talk and text from the International Pass package can't be used to avoid voice and data overage charges incurred in International Daily Pass countries.

**AT&T PASSPORT®:** One-time charge or monthly-recurring charge applies. One-time charge packages are valid for 30 days beginning on the chosen effective date, may cross two bill cycles, and expire automatically. Packages will not be prorated if canceled on or after the chosen effective date. Packages canceled prior to chosen effective date will not incur the one-time charge. Includes talk, text and data allotments for use in select International Pass countries listed at [www.firstnet.com/intlcountries](http://www.firstnet.com/intlcountries). **Talk:** Usage is calculated in full minute increments and rounded up to the next full minute increment. **Data:** Actual data speeds vary by device and location. Usage is calculated in full kilobyte increments and rounded up to the next full kilobyte increment. **Data overage:** If you exceed the amount of data allowance in your package, you will automatically be provided with additional data in increments of 1 GB at \$30 per GB. Monthly-recurring package data allowance must be used in bill period provided or will be forfeited. **Unlimited Text:** Applies only to AT&T Short Messaging Service (SMS) and Multimedia Messaging Service (MMS), and not to other messaging services or applications. Messages received are charged at domestic messaging rates. **Pay-per-use rates:** Apply when package expires, when traveling in countries not included in Passport, and/or when you have not added a package. **Service restrictions:** International use aboard cruise ships and airlines is not included. Not available for wireless home phone services, connected vehicles, or connected devices. Pay-per-use international rates, found at [www.firstnet.com/intlcountries](http://www.firstnet.com/intlcountries), will apply.

**AT&T Passport® Pro:** Monthly-recurring charge applies. Packages will not be prorated if canceled on or after the chosen effective date. Packages canceled prior to chosen effective date will not incur the one-time charge. Includes talk, text and data allotments for use in select AT&T Passport countries listed at [www.firstnet.com/intlcountries](http://www.firstnet.com/intlcountries). **Talk:** For phones only. Minute allowance must be used in bill period provided or will be forfeited. **Talk Overage:** If you use all your Passport package minutes, \$0.45 per minute charge applies to all cellular calls dialed and accepted in Passport countries. Wi-Fi Calling: With Wi-Fi Calling, you can call back to the U.S. at no additional charge. Calls to other countries, including the country you're in, are billed at international long-distance rates, found at [att.com/worldconnect](http://att.com/worldconnect). To be billed the Passport calling rate, turn Wi-Fi Calling off in your device settings. **Data:** Actual data speeds vary by device and location. If your domestic plan includes Stream Saver®, or reduces video streaming speed, the same will apply to your Passport Pro package. Data allowance must be used in bill period provided or will be forfeited. **Overage and Data Speeds:** There is no charge for overage. However, if you use all your Passport package data, all data usage is slowed to a max of 256Kbps for the rest of the bill cycle. All data usage will be impacted and may not be fully functional. **Unlimited Text:** For phones only. Applies only to AT&T Short Messaging Service (SMS) and Multimedia Messaging Service (MMS), and not to other messaging services or applications that use data, such as iMessage. Unless you have a domestic plan that includes unlimited text, messages received in Passport countries are charged at your domestic messaging rates. **World Connect Advantage:** Package also includes the AT&T World Connect® Advantage (WCA) feature at no additional charge. WCA enables international long distance calling from the U.S., Puerto Rico and U.S. Virgin Islands to (a) landline numbers in select countries and wireless numbers in a portion of those countries and (b) discounted calling to additional countries. For details on countries and rates, see [att.com/worldconnect](http://att.com/worldconnect). Rates are subject to change and may vary by country and type of number called. Domestic postpaid wireless voice plan required. For domestic postpaid wireless voice plans with capped minutes, international long-distance calls using WCA will count against the domestic plan's monthly allotment of voice minutes, and if you exceed the domestic plan's monthly allowance, overage charges will apply under the plan. **CRUISE SHIP PACKAGES:** Compatible device with domestic postpaid wireless service required. One-time charge applies. Packages are valid for 30 days beginning on the chosen effective date, may cross 2 bill cycles, and expire automatically. Packages will not be prorated if canceled on or after the chosen effective date. After expiration, pay-per-use rates will apply unless a new package is purchased. Packages apply only to select cruise lines "Cellular at Sea" Display: On-board networks operate only while in international waters. Therefore, your AT&T cruise package allowances and overage rates for usage on-ship only apply when "Cellular at Sea" displays on your device. Cruise package allowances and overage rates also apply off-ship, but only to the extent you are attached to land-based cellular in Canada, Mexico, and the Caribbean, and have no other AT&T domestic and/or international calling, texting and/or data plan that supersedes those rates.
