FirstNet and Family Plan Eligibility: Eligible and verified employees/volunteers of qualified public safety entities or entities that contribute, enable, or support public safety services to first responders and whose duties are directly related to such services. New subscribers must qualify for FirstNet service and complete verification process within 30 days. **Check eligibility at firstnet.com/eligibility.** Requires FirstNet-Capable device provisioned with a FirstNet Trio SIM or eSIM card. **LIMITS:** Maximum of 4 lines (1 smartphone, 1 tablet, 1 wearable, 1 connected device) per eligible FirstNet Subscriber Paid User. Account subject to periodic re-verification. **If you are not a valid Subscriber Paid User or exceed the single line limit for each type of device, AT&T may suspend, change or terminate your FirstNet service.** For additional information see firstnet.com/firstnetandfamily.

Up to 20% off service discount offer: Required wireless: One FirstNet 2.0 smartphone plan line of service (minimum \$54/month) and one AT&T Unlimited 2.0 plan smartphone line of service (minimum \$60/month before discounts). **Eligible FirstNet unlimited plans:** Get FirstNet Value 2.0, FirstNet Extra 2.0, FirstNet Premium 2.0, and FirstNet Elite 2.0 plan for smartphone lines of service. **Eligible AT&T unlimited plans: Plans available in select locations only.** Get 10% off AT&T Value 2.0, 15% off AT&T Extra 2.0, and 20% off AT&T Premium 2.0 plan monthly service charge for smartphone lines of service; 20% off the monthly service charge for eligible connected data device (tablet, smartwatch, hotspot, Connected Car, and camera) lines of service.
